- *Please enclose a certificate of membership from the National Society and a passport size b/w photograph to this nomination form.*

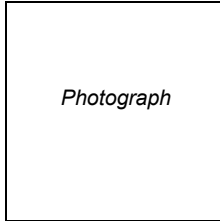
